Madan,

With reference to your application dated 17.2.98 on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition to your School from Class 1st to VIIIth (without aid) W.C.F. Academic session 1998-99 subject to the fulfilment of the following terms and conditions:

1. That the School shall strictly abide by the provisions of DSEA, 1973 framed there under as well as the instructions issued from time to time by the department.
2. That the school shall admit students without any discrimination of caste and creed.
3. That a proper Library shall be established and facilities for the reading room shall also be made available to the students as well as the teachers. Books in the ration of 10 books per student shall be purchased and made available to the students.
4. That adequate sports material shall be purchased and made available to the students.
5. That the employees of the School will be given pay and allowances and other prescribed benefits as provided for under section 10(1) of the DSEA, 1973 and Rule 125 of DSEA, 1973.
6. That the School shall not run any unrecognised classes or conduct any other activities within the School premises as per Rule 50 of DSEA, 1973 and all the recognised classes shall be run at one place.
7. That the school shall dispense with the services of unqualified and over aged staff, if any, immediately and the required staff strength must be complete in all respects as per norms.
8. That the school shall submit returns to the Act Branch of the Dte. of Education as per Rule 180(1) of DSEA 1973 annually.
9. The Managing Committee of the School shall regulate the functioning of school strictly in accordance with the provisions of DSEA and Rule 1973.
10. The Managing Committee of the School shall not increase fee in the future academic sessions without the prior intimation/approval of the Director of Education which is a mandatory requirement under sub-section 17(3) of DSEA 1973.

12. Proof to the effect that qualified staff has been appointed as per R.Ss be provided for verification by the Education Officer.
13. That the arrangements for good drinking water shall be made for all the students and the staff adequately.
14. The School shall have the medium of instruction as per Rules 6, 7 and 8 of DSEA, 1973.
15. Provident Fund register shall be maintained and the Cash Book completed and shown to the E.O. of the zone concerned for verification from time to time.
16. That the management of the school shall create a reserve fund equal to three months salary of the staff in the joint name of Director of Education and the manager of the School in any scheduled Bank within a month.
17. That the violation of any instructions/conditions/rules and regulation of the department shall lead to action against the school as per section 21 of DSEA, 1973.
18. That report about the fulfilment of the above conditions shall be sent to the Education Officer every year.
19. That the school shall equip the Science Laboratory as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
20. All the conditions of recognition under section 4 of the Act will continue to be complied with.
